DEREGISTERED? DISMISSED? WHAT NOW?

Presumably you had hoped to be hired on a permanent basis by the company you were deployed to. Now, however, you have been deregistered. You might be unable to get deployed for a long time afterwards. You might even be dismissed by your temporary employment company. Should that happen, you can rest assured that this has nothing to do with you personally. **Nevertheless, there are a few things you should bear in mind in the event of dismissal.** We have summarised them for you on the **reverse**.

IG Metall is at your side in all situations. Important: If you are unemployed, you should stay a member. In this case, you will only pay a reduced membership fee, but retain all membership benefits, from individual advice and support to legal protection in matters related to labour and social law. Simply inform your local IG Metall branch.

And if you remain a member, you can also **secure the right to the extra payment on top of your holiday pay and Christmas bonus:** If you return to temporary employment, you already meet the requirement of six months of membership.
